 - A. HHW AND UW Schedule: September 20, 2025 has been confirmed by both contractors. The collection will be held in the back parking lot at MDI High School, same as last year. Information sheets will be sent out in the next few days. 9-10 a.m. will be for the out-island trucks. 10 a.m. to 2:00 p.m. will be for cars delivering HHW and UW from the MDI towns and other adjacent towns.
 - B. Municipal Waste Hub in Hampden update. Municipal Waste Hub has and purchased tractor trailers for "Hub and Spokes" pick-up. This will allow pick-up of products (metal, for example) with one large truck picking up at a variety of sites rather than multiple towns driving to Municipal Waste Solutions.
 - C. Website update, if any. The ADD website has not promoted the Sept. 20 date for HHW and UW. That will be corrected soon!
 - D. Congressionally directed spending update. Tony Smith has been working with Acadia National Park and our Congressional Offices to change our original goal for Congressionally Directed Spending. The original goal was to build a shed on EMR property so that locals could more conveniently deposit HHW and UW that would be sent to Environmental Products, Inc. and

Instead we are now working with a variety of stakeholders to see if together we can cap the former landfill at EMR so that it is no longer leaching unwanted chemicals into Marshall Brook which travels through Acadia National Park land and empties into the Bass Harbor Marsh and then to Bass Harbor itself. Jim Vallette has researched the long history of the abandoned landfill. We hope to find a solution that will be to everyone's benefit.
